The Texas & Pacific Railroad arrived in Fort Worth in July 1876, bringing the need for more lodging. Shortly after its arrival, boardinghouses and simple accommodations were quickly opened. At the turn of the century, Fort Worth became a center for cattle ranchers, and the first luxury hotels were built. Through the literature of the church, Professor Maguire concludes, the methods of rhetoric indirectly helped Byzantine artists add vividness to their narratives, structure their compositions, and enrich their work with languages. Once translated into visual language, the artifices of rhetoric could be appreciated by many. Henry Maguire is Assistant Professor of Art History at the University of Illinois at Urbana-Champaign.
